In 2020, one of our Co-Founders, Nick Williams came up with an innovative idea together with Tsolak's inspiration had grown into a movement, and that movement matured into a company committed to rewarding for all players, at all levels, so all players could focus on what they do the best: train, compete and win without worry about money while getting rewarded by TNNS Tokens.

In 2021, TNNS Pro LLC was formally founded in New Jersey that will change the world in sports. Our goal is to give everyone a complete experience within the TNNS token ecosystem.

## Proof of Stake (PoS) Consensus Mechanism

Proof of Stake (PoS) gives mining power based on the percentage of coins held by a miner. And In a proof-of-stake model, TNNS put up our tokens as collateral. In return, TNNS get authority over the token in proportion to the amount we stake.

Generally, these token stakers get additional ownership in the token over time via network fees, newly minted tokens or other such reward mechanisms which is perfect for TNNS Token. The whole process uses marginally more energy than a computer would if it was just on. Researchers believe that the result is that energy consumption for proof of stake is 99.99 percent lower than proof of work. Proof of Work (PoW) requires huge amounts of energy, with miners needing to sell their coins to ultimately foot the bill and that is why TNNS uses PoS instead of PoW. Not only does it provide efficiency, but also it is cost effective and future-proof.

Proof of stake is already working. Cardano uses proof-of-stake and has the fourth-largest market capitalization — \$50 billion — of any cryptocurrency as of mid-May. It is currently the most significant proof of stake cryptocurrency on the market and other already functioning cryptocurrencies that use proof of stake include Polygon, Tezos, Polkadot and EOS.

Proof of Stake (PoS) system is used in TNNS Token and TNNS Token shall be the future of the blockchain and might be the next bitcoin in the near future.



## **BEP20 token on **Binance Smart Contract Standard****

BEP20 is the Binance Smart Chain equivalent to the popular ERC20 specification for tokens on the Ethereum network. The difference is the BEP20 Token is not run on the Ethereum Network, but the Binance Smart Chain network.

The reason why TNNS has chosen BEP20 Token on Binance Smart Contract was because Binance Smart Chain is an ecosystem of phenomenal crypto-assets where the transaction fee is less and highly secured.

They are highly performative in a blockchain. It is integrated with a cross-chain DeFi mechanism. BSC supports bootstrapping and funding of other DeFi projects. Several blockchain systems also collaborate with BSC. Binance Smart Chain is also used as a platform for developing and launching other tokens.

### **Other benefits**

- A wide variety of things are being represented through these tokens like cryptos, fiat currencies, etc.
- Tokens from various blockchain networks can be pegged on this token.
- A smart contract can be embedded on the smart chain network.
- An incentive for the validators on the network
- Cross-chain compatibility facilitates flawless swapping of BEP-2 tokens equivalent to BEP-20 tokens with the Binance Chain Wallet extension.



## What is **TNNS Tokens**?

TNNS Token is a crypto digital token. The TNNS token uses binance protocol. This means that it is very secure and will have real-world value, once we have added it to an exchange. TNNS is a cryptocurrency designed to reward all athletes, regardless of gender, age, level and sport.

**Our mission is simple:** incentivize participation and performance in sport by ensuring ALL athletes receive attention, exposure and proper compensation (in the form of TNNS) for their years of training, competing and sacrificing for their craft. Since we know that many athletes in most sports - including women's basketball - do not receive the opportunities they deserve, we are addressing the problem.

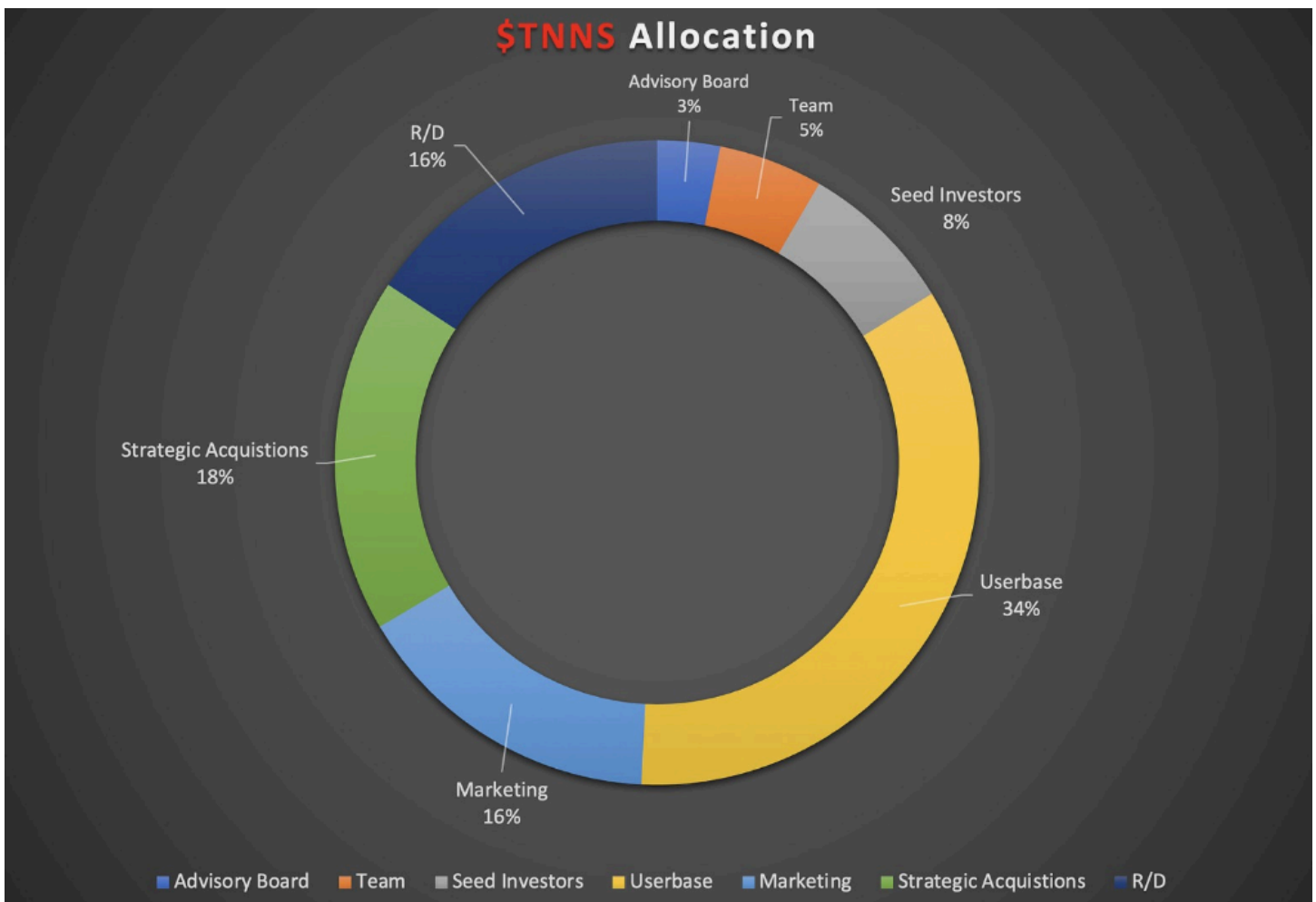
Our system is designed to boost topnotch security, thus making it tamper-proof. Running on secure Blockchain, our system is configured to offer degree security, which reflects on our token.
